**ORDER**

The above matter came on before the undersigned based on a recommendation made by Special Master Van de North on December 16, 2015:

WHEREAS, on October 30, 2015, the Court entered a Bellwether Selection Order specifying a process by which Plaintiffs' counsel and Defendants' counsel would work with Special Master Van de North to select 40 bellwether discovery plaintiffs.

WHEREAS, the Parties met and conferred pursuant to the Bellwether Selection Order and worked with Special Master Van de North to select the 40 bellwether discovery plaintiffs.

WHEREAS, by letter dated December 16, 2015, Special Master Van de North recommended 40 bellwether discovery plaintiffs to the Court.

WHEREAS, the matter came before the court at the December 18, 2015 hearing.

NOW THEREFORE, in consideration of the foregoing, it is hereby ordered that:

1. The 40 plaintiffs recommended by Special Master Van de North, and attached hereto as Exhibit A, are selected as bellwether discovery plaintiffs.
2. The discovery stay is lifted with respect to the 40 plaintiffs identified in Exhibit A, pursuant to Scheduling Order No. 2 entered on November 4, 2015.


